Issue: Webadmin - Unable to edit the location with the name 'Service Call Entry/Update'

<u>Issue:</u> Order of Creation of User/Group permission interferes with display of Additional menus in GP

Bug #5353

<u>Issue:</u> GP Auto Update-→ An invalid message is displayed when GP is launched and the KwikTag server is turned off. Cannot log in to Great Plains client if the KwikTag server is offline.

Bug #5074

<u>Issue:</u> Global Search – When any 'Within' option is selected (excluding 'Date Range'), changing the option in the 'By System Field' dropdown the date field remains enabled

Bug #5070

Issue: Global Search - Clicking 'find' clears the values in the 'From' and 'To' date fields

Bug #4993

<u>Issue:</u> Web User Client – Clicking on 'My New Documents' (when browsing drawers) displays the old user experience

Bug #4619

<u>Issue:</u> SharePoint Connector – When a connector-only installation is done the KwikTag metadata does not carry over into the SharePoint Document Library

Known Issues

Bug #5788

<u>Issue:</u> Sharepoint Connector – Document data not getting reflected in SP for Receivables Transaction Entry, Purchasing Entry, Purchasing Rec Trans Entry

<u>Workaround</u>: Make the 'Vendor Id' field optional in Sharepoint for the Purchasing Order Entry, Purchasing Rec Trans Entry and Payables Transaction Entry. Also make the 'Number' field optional for Receivables Transaction Entry

Bug #5630

<u>Issue:</u> Office DoKs – Sometimes a local administrator must first use 'Send To KwikTag' from Office or Windows Explorer before a non-administrator user can use that feature
